

**ADVERTISEMENT FOR BID**

The City of Albion will receive bids for the construction of the 2021 Utility Extensions Project until 10:30 a.m., local time on the 19th day of January, 2021, at the Albion City Hall, 112 West Cass Street, Albion, Michigan, 49224 at which time all bids will be publicly opened and read aloud.

The work for which bids are being requested is located on Haven Road, S. Hannah Street, and 29 Mile Road. The work for which bids are being requested consists of pavement removal, water main and appurtenances, sanitary sewer, machine grading, ditching, subbase, aggregate base, concrete curb and gutter, HMA paving, pavement markings and slope restoration.

Neither the OWNER nor the ENGINEER will be responsible for partial sets of documents obtained from any other source. Electronic sets of plans and specifications are available for free via the company's website. The City of Albion reserves the right to reject any or all bids and to waive any irregularities in bidding.

A certified check or bank draft drawn on a solvent bank in the State of Michigan payable without condition to the City of Albion or a satisfactory bid bond executed by the bidder and a surety company, in an amount equal to 5 percent of the bid shall be submitted with each bid.

No bids may be withdrawn after the scheduled closing time for receipt of bids for a period of sixty (60) days to allow the review of proposals and to allow completion of necessary financial arrangements.

The successful bidder will be required to furnish a satisfactory Performance Bond and Payment Bond in the amount of 100 percent of the Contract price. Bond forms are included in the Contract Documents.
