The City of Watervliet will receive sealed bids for the construction of the Elm Street Improvements Project until 2:00 p.m., local time on the *18th* day of *February*, 2021, at the City Hall office, P.O. Box 86, Watervliet, Michigan 49098, at which time all bids will be opened and read publicly via videoconference at the meeting link provided below.

The work for which bids are being requested consists of the following:

**Base Bid Contract**

Includes approximately 3,505 SYD HMA surface removal; 2,485 LFT curb and gutter removal; 470 TON HMA, 13A; 285 TON HMA, 36A; 2,520 LFT concrete curb and gutter; 1,340 SYD sidewalk removal; 12,100 SFT concrete sidewalk; 10 LFT 6" DR 14 PVC pipe water main; 1,230 LFT 8" DR 14 PVC pipe water main; 1,120 LFT 1" Type K Copper pipe water service; 23 EA 1" water service connections; 23 EA building reconnections; 316 LBS compact ductile iron fittings; restoration; and various appurtenances along Elm Street from North Pleasant Street to First Street.

**Alternate A – Pressure Class 350 Ductile Iron Pipe Water Main**

Includes approximately 10 LFT 6" Pressure Class 350 Ductile Iron pipe water main and 1,230 LFT 8" Pressure Class 350 Ductile Iron pipe water main. Alternate A is included as an alternative to the DR 14 PVC pipe water main included as part of the Base Bid Contract.

**Alternate B – SDR 9 CTS HDPE Pipe Water Service**

Includes approximately 1,120 LFT 1" SDR 9 CTS HDPE pipe water service. Alternate B is included as an alternative to the Type K Copper pipe water service included as part of the Base Bid Contract.
