A certified check or bank draft drawn on a solvent bank in the State of Michigan payable without condition to the OWNER or a satisfactory bid bond, meeting US HUD minimum bonding requirements (5%) as expressed at Form HUD-5369 Instructions to Bidders, Clause 9, executed by the bidder and a surety company shall be submitted with each bid.

No bids may be withdrawn after the opening of the bids for a period of sixty (60) days.

The successful bidder will be required to furnish a satisfactory assurance of completion in conformance with HUD Form 5369 Instructions to Bidders (Clause 10).

The Nottawaseppi Huron Band of the Potawatomi reserves the right to reject any or all bids and to waive any irregularities and informalities in bidding.
