**ADVERTISEMENT FOR BID**

The City of Holland will receive sealed bids for the construction of 6<sup>th</sup> Street until 4:00 pm, local time on the 22<sup>nd</sup> day of November, 2022, at the office of City of Holland Transportation Services Department, 333 Wyngarden Way, Holland, MI 49423 at which time all bids will be publicly opened and read aloud.

The work for which bids are being requested consists of the following:

Reconstruction of 6<sup>th</sup> Street from River Avenue to Columbia Avenue, College Avenue from 8<sup>th</sup> Street to 6<sup>th</sup> Street and Columbia Avenue from 7<sup>th</sup> Street to 6<sup>th</sup> Street. The work will include HMA surface removal, pavement removal, roadway grading, aggregate base, HMA surfacing, concrete curb and gutter, snowmelt, brick pavers for driveways, sidewalks and ADA ramps, storm sewer improvements, sanitary sewer and laterals, water main and services, electrical conduits, jack and bore of steel casings, permanent signs and pavement marking, and slope restoration.

The bid also will include an alternative bid to snowmelt the roadway and parking areas between College Avenue and Columbia Avenue.

Neither the OWNER nor the ENGINEER will be responsible for partial sets of documents obtained from any other source. The Advertisement for Bids, Plan Holder's List, all Addenda, and the Bid Tabulation will also be posted on the Wightman website bidding page at [www.gowightman.com/bids](http://www.gowightman.com/bids).

In addition electronic plans are being made available for review through Builders Exchange Grand Rapids, Builders Exchange Lansing, and Builders Exchange Kalamazoo.

Hard copies of the plans and specifications may be obtained at the office of the ENGINEER, Wightman, 1670 Lincoln Road, Allegan, MI 49010, at a non-refundable cost of Seventy-Five Dollars (\$75.00) for each set of documents so obtained. An additional cost of Twenty-five Dollars (\$25.00) will be charged for bid sets requiring shipping and handling.

The OWNER reserves the right to reject any or all bids and to waive any irregularities in bidding. The use of local contractors and labor is encouraged.

A certified check or bank draft drawn on a solvent bank in the State of Michigan payable without condition to the OWNER or a satisfactory bid bond executed by the bidder and a surety company, in an amount equal to 5 percent of the bid shall be submitted with each bid.

No bids may be withdrawn after the scheduled closing time for receipt of bids for at least ninety (90) days.

The successful bidder will be required to furnish a satisfactory Performance Bond and a Labor and Material Bond in the amount of 100 percent of the Contract price. Bond forms are included in the Contract Documents.
