## **ADVERTISEMENT FOR BID**

The City of Holland will receive sealed bids for the construction of the Van Raalte Reconstruction Project until 4:00 pm, local time on the *3rd* day of *May, 2023*, at the office of City of Holland Transportation Services Department, 333 Wyngarden Way, Holland, MI 49423 at which time all bids will be publicly opened and read aloud.

The work for which bids are being requested consists of the following:

Reconstruction of Van Raalte Avenue from 10<sup>th</sup> Street to 11<sup>th</sup> Street, 10<sup>th</sup> Street from Van Raalte Avenue to Washington Avenue, 11<sup>th</sup> Street from Kollen Park Drive to Maple Avenue, Kollen Park Drive from 12<sup>th</sup> Street to 11<sup>th</sup> Street. The work will include HMA surface removal, pavement removal, roadway grading, aggregate base, HMA surfacing, concrete curb and gutter, concrete driveways, sidewalks and ADA ramps, storm sewer improvements, sanitary sewer laterals, water main and services, permanent signs and pavement marking, and slope restoration. Milling and resurfacing of Kollen Park Drive from 16<sup>th</sup> Street to 12<sup>th</sup> Street. This work is intended to take place during the 2023 construction season as Phase 1.

The bid also will include an alternative bid for ductile iron water main on Phase 1. Also includes a future phase (Phase 2) for the Reconstruction of Van Raalte Avenue from 11<sup>th</sup> Street to 24<sup>th</sup> Street, if the City elects to award it for the 2024 construction season.

The OWNER reserves the right to reject any or all bids and to waive any irregularities in bidding. The use of local contractors and labor is encouraged.

A certified check or bank draft drawn on a solvent bank in the State of Michigan payable without condition to the OWNER or a satisfactory bid bond executed by the bidder and a surety company, in an amount equal to 5 percent of the bid shall be submitted with each bid.

No bids may be withdrawn after the scheduled closing time for receipt of bids for at least ninety (90) days.

The successful bidder will be required to furnish a satisfactory Performance Bond and a Labor and Material Bond in the amount of 100 percent of the Contract price. Bond forms are included in the Contract Documents
