Bids for the construction of the Project will be received at the City of Albion City Hall located at 112 W. Cass Street, Albion, MI 49224, until **Tuesday, June 25, 2024 at 10:00 a.m. local time.** At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

The proposed Water Treatment Plant (WTP) Improvements include replacement of the high service pumps, replacement of the potassium permanganate mix-down system, replacement of the chemical feed pumps, rehabilitation and coating of the aerators, replacement of the filter media, replacement of butterfly valves and an air release valve, updates to the plant SCADA and electrical systems, recoating of piping, bolts, and pipe stands, replacement of building roof, renovation of laboratory space, addition of a vestibule area, upgrades to the electrical, plumbing, and HVAC systems, improvements to the Clark Well Building #1 structure, replacement of the flow meters at Clark Well House No. 1, Star Well House No. 1, and Star Well House No. 2.
