The work for which bids are being requested consists of the following:

### Contract A – Septic System

Construction of an onsite wastewater treatment and disposal system including sewer service, septic tanks, dosing station and absorption field. This contract also includes the redirection of existing storm sewers around the field, removal of a portion of the parking lot, patching and overlaying the existing parking lot, SESC measures and restoration of the lawn areas disturbed as part of the site work and various appurtenances and alternatives.

# <u>Contract B - MEP, Fire protection tank/pump and Well</u> construction of the following:

- Boiler and domestic hot water system replacements
- AHU/RTU/unit ventilator upgrades and replacements
- Mechanical piping distribution system
- Electrical distribution and grounding systems
- Exterior and parking lot lighting
