**ADVERTISEMENT FOR BID**

The City of Hartford will receive sealed bids for the construction of the W. Main Street Improvements Project until 10:00 a.m., local time on the 24<sup>th</sup> day of *February*, 2026, at the office of the City of Hartford at 19 W. Main Street, Hartford, MI 49057 at which time all bids will be publicly opened and read aloud.

The work for which bids are being requested consists of the following:

**Contract**

The project includes full roadway reconstruction and water main replacement on W. Main Street from the western City Limits to Center Street, including approximately 200' of each approach at Center Street. Included in the project is HMA removal and replacement, miscellaneous curb and gutter replacement, water main replacement, water services, miscellaneous sidewalk improvements, signage, pavement markings, pedestrian signal improvements, and restoration and various appurtenances.

A printed copy of the Contract Documents including plans and specifications is located at the City Hall and may be reviewed during City office hours. Neither the OWNER nor the ENGINEER will be responsible for partial sets of documents obtained from any other source. The Advertisement for Bids, Plan Holder's List, all Addenda, and the Bid Tabulation will also be posted on the Wightman website bidding page at [www.gowightman.com/bids](http://www.gowightman.com/bids).

The OWNER reserves the right to reject any or all bids and to waive any irregularities in bidding. The use of local contractors and labor is encouraged.

A certified check or bank draft drawn on a solvent bank in the State of Michigan payable without condition to the OWNER or a satisfactory bid bond executed by the bidder and a surety company, in an amount equal to 5 percent of the bid shall be submitted with each bid.

No bids may be withdrawn after the scheduled closing time for receipt of bids for at least ninety (90) days.

The successful bidder will be required to furnish a satisfactory Performance Bond and a Labor and Material Bond in the amount of 100 percent of the Contract price. Bond forms are included in the Contract Documents.

This project is being funded in part through a grant from the Michigan Economic Development Corporation, Water Related Infrastructure Grant Program. The CONTRACTOR shall comply with all requirements of this granting agency.

The bidder's attention is called to the "Notice of Requirement for Affirmative Action to Insure Equal Employment Opportunity" (Executive Order #11246), contained in the bid documents, which sets forth, in part, goals and timetables for the employment of women and minorities in the project area. CONTRACTORS must apply every "good faith effort" to see that minorities and women comprise a portion of each construction trade on this project and to the maximum extent feasible, lower income persons are given employment opportunities and businesses located in the community are given contract opportunities.

CONTRACTORS and subcontractors are required to pay not less than the prevailing rates established by the U.S. Department of Labor, which are included in the project specifications. Information explaining other prevailing wage laws which apply to this work are also contained in the project specifications. The CONTRACTOR must comply with the Davis Bacon Act, July 2, 1965 (Title 40S 276A), the Equal Employment Opportunity Act, September 28, 1965, No. 11246, all United States Department of Labor regulations and Standards Title 29, 1, 2, 5 and Title 18 U.S.C. Section 874 known as "Anti-Kickback Act", and the Federal Occupational Safety and Health Act of 1970.
